Dear Parents/Carers

I hope as ever this letter finds you all well and settling back into the swing of the term. With the change in the hour last weekend it is important that everyone is very vigilant on the darker evenings. The mornings are slightly lighter for now but again with the onset of winter it important we are all keeping ourselves safe.

#### COVID-19

Can I please ask you to discuss the following with your young people at home?

Mitigations – masks, one way systems, designated social areas displayed around school and if not sure please ask, hand sanitising and LFD testing.

We have been advised that the number of people carrying out LFD testing in Moray has dropped slightly. Can I please encourage you to ensure you have a supply of LFD testing kits and that these are used regularly. We advise that testing is completed on a Sunday before coming to school on Monday and a Tuesday evening or Wednesday morning before coming to school on Wednesday.

In schools we are living under much greater restrictions than elsewhere in society and as a result it is really important we maintain our high COVID-19 standards to ensure we keep everyone in the community safe and well.

## **SQA** and Prelims

We continue to monitor advice from the SQA regarding the May diet of exams. We are also awaiting details related to prelims and as ever, as soon as we have any further information we will share this with yourselves and your young people.

#### **Tracking and Monitoring**

You will all be aware that we produce what we call Tracking and Monitoring reports on a regular basis to keep you informed of your young person's progress.

I am aware that you may not know when these reports are due so included at the end of this Newsletter is a summary of these timings. Please be aware that as COVID-19 situations can change these dates may be subject to alteration.

Note that if there are changes in the required COVID-19 mitigations then full reports will be replaced with parents' evenings.

#### **CyberFirst Girls Development Day**

The girls were role playing as cyber security experts working for a fictitious company, Sirius Cyberworks. Disaster had struck and there had been a serious breach of the company network, with a new flagship app having been leaked. The girls worked through four different parts of the company, uncovering how the leak had happened whilst learning new cyber skills along the way.

This virtual event took place using MS Teams, with pupils working in teams with others from around the UK to solve problems to uncover the source of the leak. Using a virtual PC and network, on Day 1 they developed skills in Digital Forensics, learning how to find and capture evidence from a hard disk, and Cryptography, learning how codes can be hidden - and found - in image and audio files.

On Day 2 they used hacking tools to develop skills in Penetration Testing, discovering how to steal usernames and passwords from an insecure website and how the company's website was hacked to display a message on the home page. Finally, they worked collaboratively to put all their new skills into action to solve a team challenge, with two of our pupils in the winning team.

Overall, the girls enjoyed the event, finding it both challenging and exciting, and most are keen to take part in another event in future.
